Terms and Conditions

OWNERSHIP RIGHTS AND RESPONSIBILITIES:

Photographer and Client agree that unless stated otherwise in this document, Photographer owns any and all copy or reproduction rights. Client agrees to not reproduce or copy any digital images or other photograph of the event, taken by Photographer, without Photographer's written permission. Any unauthorized reproduction of digital images constitutes a breach of this agreement and will subject Client(s) to any and all applicable civil penalties. Photo CD's, if provided, will include a Photographer Release allowing reproduction of images for personal use.

RETAINER AND PAYMENT REQUIREMENTS:

To reserve the event date, Prints Charming requires a non-refundable deposit of 1/3 of contract total. Photographer will not hold any date open without receipt of said retainer. Prints Charming must receive the remaining balance on the date of event.

PHOTOGRAPHER DISCLAIMER:

Photographer agrees to return deposit to client in the event of nonperformance or non-delivery caused by Photographer. Client acknowledges that the dyes used in color photography, like all other dyes, may fade or discolor in time, and, accordingly, client waives any and all claims resulting from such occurrences. Client further acknowledges that the technology used to photograph the event and the mediums in which events are recorded on are subject to mechanical failures and faulty mediums. In the event of non-delivery caused by such events Photographer and Client agree that Photographer is not responsible for any other damages, emotional or otherwise. Photographer is not responsible for inclement weather prohibiting outdoor photography.

EXCLUSIVITY:

Other persons may take photographs at the wedding and reception, however all "formal" or other shots set up by photographer are for photographer to photograph exclusively. It is the Client's responsibility to inform all guests of said policy.

DELIVERABLES:

Photo CD's and/or DVD's shall be delivered within 6-10 weeks after date of event covered. Client is responsible for notifying Prints Charming upon receipt as to the level of satisfaction with products. Edited images will be available online for viewing, sharing and purchase once completed.

PHOTO BOOK:

Client is to select 50 images from their Photo CD that they would like to appear in their Photo Book. Selected image numbers are to be emailed to Prints Charming and then the Photo Book will be designed, ordered and shipped. Images included in layout of any and all Photo Books will be identical. If client desires different images for each Photo Book a fee of \$25 per Photo Book will apply for each Photo Book layout after the initial book layout. These additional fees must be received prior to order being placed. Tracking information will be emailed to client upon receipt.

LIGHTING:

All videography shall be done under existing lighting conditions. Flash photography will be available only with an on-camera flash for photography.

CANCELLATION:

If the cancellation occurs within the thirty days prior to the event a charge of \$300.00 will be due or deducted from any payments before a refund is given.

RESCHEDULING:

If your event date changes from the one stated in this agreement you may reschedule to any other available date. In the event that Prints Charming is not available the cancellation policy above will be enacted. A new agreement must be signed with the new dates.

Our Wedding Day Highlights DVD \$300

The Wedding Day Highlights DVD is perfect for when you want to share a condensed version of your wedding day with family and friends. Your Wedding Day Highlights DVD will contain the exchanges of vows and rings, and excerpts from the reception such as the first dance, the cutting of the cut, the toast, garter and bouquet toss. Your Wedding Day Highlights Video will run approximately 10-20 minutes and will be presented on a separate DVD.

Bride and Groom Interviews \$300

Express your feelings for one another before your wedding day to cherish in years to come. Audio interviews of the Bride and Groom (done separately) will be done approximately four to six weeks prior to the wedding. The interviews will be skillfully edited and utilized as voice-overs on the Highlight Video. This makes for a unique and personal video presentation.

Life Story Montage \$200

The Life Story Montage of the Bride and Groom as told through images of the Bride and Groom growing up and dating. May be set to background music or voice-overs from the parents, Bride and Groom. (Up to 50 photos. Each additional photo is \$3.00.)

Love Story Video \$600

The Love Story is told by the Bride and Groom as they share the story of how they met, fell in love and decided to get married. Typically shot in a local park setting (i.e., Town Point Park, Botanical Gardens) or the place where the Bride and Groom met (if possible, and local). The Love Story averages 7-15 minutes in length and has subdued background music.

Rehearsal Dinner Coverage \$75/hr (one hour minimum)

This is not a common service we are asked to provide, but there are those occasions where there is special entertainment or presentations that you would like to have captured.
